- Municipal Birth Certificate (Attested photocopy by any Gazetted Officer) will be submitted at the time of admission in case of those seeking admission for the first time or coming from unrecognized school.
- 2. Student seeking admission to class IX & X must produce "a pass certificate in third language in their previous school."
- 3. If belongs to SC/ST/OBC, a certificate should be submitted.
- Other than Class Nursery & KG, no admission is complete until Transfer Certificate in original from the last school is produced. (It should be countersigned by Education Officer in case of Non CBSE or Inter-State Transfer).
- 5. Attested photocopies of certificate for proficiency in Games, CCA, other outstanding achievements and Report Cards of last three years are to be submitted at the time of Registration.
- 6. Any person than parent is required to submit an authority letter from the father/mother of the ward to sign any paper to make any correspondence with the school as their representative.

DECLARATION:

- I know that the <u>Registration Fee is non-refundable</u> and registration is not binding for admission. It may be given only. Also not that ADMISSION FEE will not be refunded after seeking admission in the Academy.
- 2. In case my child is admitted in the school, I shall make my own arrangement for inoculation against typhoid, cholera & vaccination against small pox etc. to my child from year to year.
